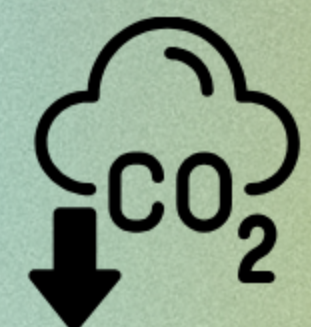
Introduction

This Sustainable Procurement Guide is designed to support departments in integrating sustainability principles into their purchasing decisions. The guide promotes environmentally responsible procurement practices that contribute to resource conservation, waste reduction, energy efficiency, and overall sustainability. By referencing supplier survey scores and specifications outlined within this guide, departments can align their procurement activities with broader organizational goals and commitments to sustainability.

Objective

One of the core objectives of the guide is to encourage departments to prioritize goods and services that meet recognized sustainability certifications and standards. The Guide covers certifications in different environmental aspects, focusing on decarbonization, circular economy practices, energy efficiency, water conservation, and responsible forestry. By selecting products that comply with these specifications, departments reduce their environmental footprint while stimulating market demand for sustainable goods and services, driving positive change across industries.

Sustainable Procurement Scoring System

A key feature of the guide is the scoring system designed to communicate environmental impacts of goods and services to internal users and encourage sustainable procurement. The Purchasing Department will distribute supplier surveys to suppliers by phase and request information on the listed environmental specifications. For each sustainability specification fulfilled, one to three points will be awarded and be counted towards an overall score. The overall score highlights goods or services' relative sustainability performance, and will be shared as soon as available with internal users for their consideration in future purchases. A higher score reflects the added value and impact of more sustainable products. More points will be awarded to environmental specifications that align with Regal Hotels sustainability priority areas (i.e. decarbonization). Departments are encouraged to consider higher-tier sustainable products and services where feasible throughout the procurement process.

Goods and services with certifications demonstrating reduced negative environmental outside the latest Sustainable Procurement Guide would be considered for points by staff responsible for sustainable development on a case-by-case basis.

With this Sustainable Procurement Guide, departments can systematically enhance sustainable purchasing efforts, and progressively develop leadership in environmental stewardship.

Review

The Group will review this Guide from time to time as appropriate, and in any event, once a year.
